Peter joined the IAPD in 1980 as the Association's General Counsel and was responsible for the initiation and passage of landmark legislation pertaining to park districts, forest preserves, conservation districts, recreation, and special recreation agencies on statewide and national levels, including the Open Space Lands Acquisition and Development Program (OSLAD), which has provided more than \$617 million in grants to these agencies. Matched locally, this has resulted in more than \$1.5 billion dollars being invested in the outdoor recreational infrastructure of communities throughout Illinois. As IAPD President and CEO, he has extensive experience in transitional leadership, customer service, and organizational design and development. He manages the Association's day-to-day operations and personnel and works with the IAPD Board of Trustees on the development and implementation of strategic plans and member-centric goals. He is a prolific author and actively establishes corporate and nonprofit partnerships and directs all Association programmatic activities and services including advocacy, research, board member training, publications, education, public awareness, and marketing. Peter received his Bachelor of Science Degree from the University of Michigan and his Juris Doctorate from the New England School of Law in Boston, Massachusetts. In 2003, he was inducted into the American Academy for Park and Recreation Administration. In 2024, Peter was inducted into the Illinois Conservation Foundation's Illinois Outdoor Hall of Fame for his work promoting the preservation of open space and the development of parks and recreational facilities for all Illinoisans. He was awarded the prestigious Cornelius Amory Pugsley Medal for Parks and Conservation from the American Academy for Park and Recreation Administration in 2024 for his outstanding contributions to the promotion and development of public parks and conservation in the United States.

IPARKS POWER GRANT

The IPARKS Power Grant is customizable and provides each member the power to choose how to use its grant funds. Each entity is eligible for either \$500, \$1,000, or \$1,500 in Power Grant funds dependent on contribution amount. In addition to safety items, the Power Grant can be used for any of the following items:

Training and Education: Expenses incurred in providing training to prevent or reduce liability claims or property losses. Examples include:

- Employment and HR training
- Cyber awareness and security training
- Certified Playground Safety Inspector (CPSI) certification
- First aid, lifeguard, CPR and AED training
- Certified Pool and Spa Inspector training

Playground Safety: Expenses incurred in repairing or replacing playground surfacing or equipment that is outdated, broken, or in need of upgrading or repair. Examples include:

- Rock climbing walls/handles
- Swings
- Slides
- Monkey bars
- Playground safety signage
- Playground surfacing materials

Risk Control: Expenses incurred in implementing risk control best practices. Examples include:

- Grounds and road inspections and safety best practices
- Prepping parks for summer or winter activities
- Tree inspections and trimming
- Sidewalk and trail inspections
- Pool safety



The Aquatics Reimbursement Program promotes pool operation education and training. Under this program, IPARKS reimburses members up to **\$500** annually for training and auditing services provided by the following approved aquatic training vendors: Jeff Ellis and Associates, Starfish Aquatics Institute, and American Red Cross.



SWING MODIFICATION/ FALL PREVENTION REPAIR

We are excited to announce an amendment to one of our grant reimbursement programs that will address not only a major safety concern, but a claims issue as well. Each IPARKS member is eligible for up to \$350 in reimbursement for expenses paid to fix a slip or trip hazard. For 2025, members may choose to utilize either the Swing Modification or the Fall Prevention Repair.
